GENERAL STATEMENT OF POSITION:

Build relationships with Siksika Nation and its surrounding communities. To connect with the Siksika Vulnerable population, Siksika High-Risk Youth and families and to connect them with the proper resources. They will provide ongoing support, develop case plans, and build relationships and collaborations with on-reserve and off-reserve resources. (ex: Treatment facilities, AA Meetings, Family Support groups, etc.) To work with Gleichen RCMP and the Police and Crisis Team "PACT" unit. The mobile support worker will support the individual's needs and goals, referrals, and transition to other services. Mobile Outreach is a diversion program that will also focus on mitigating the impacts of street-level social disorder, addiction, and public intoxication. Walking the Wolf Trail is an agile and flexible team that responds as needed to best help Siksika families and community members.

REPORTS TO: Outreach Manager DUTIES AND RESPONSIBILITIES:

- Visit known places of Siksika's Vulnerable population.
- Work collaboratively with the program Executive Director and Manager to conduct case plans.
- Assist Siksika families and youth with accessing resources and making referrals.
- Maintain computerized client records if requested, daily activity logs, and other reports as directed.
- Wellness checks (safety checks), or conflict resolution •
- Provide Counseling services.
- Goal Setting with individuals. •
- Initiate collaborations with community resources that meet needs •
- Help organize, attend and assist with monthly outreach meeting updates. •
- Successfully organize and manage files on a centralized database.
- Attending regular staff and support group meetings determined by your manager.
- Complete all paperwork accurately and on schedule.
- Knowledge of and ability to access community resources on behalf of clients.
- Assist distressed clients, prevent further escalating issues, and stabilize situations. Provide follow-up service.
- Willing to attend recommended trainings.
- Work independtly or as a group is an asset.
- Commitment and occasional flexibility is required
- Effective Communication Skills
- Must be drug and alcohol free

EDUCATION AND EXPERIENCE:

- Related field experience accepted with a minimum of two (2) years of direct work with the Vulnerable/highrisk populations and Human Services Diploma. However related experience and relevant training will be considered.
- Demonstrated ability to explain an agency's purpose, programs, and operations.Knowledge of available community resources
- High School diploma or equivalent.
